**Note:**

- (1) We have applied for the registration of the trademark on 9 June 2025 and as at the LPD, the trademark is currently under substantive examination by MyIPO. Notwithstanding that the application for registration of the trademark with MyIPO is still pending or even in the event of the application for registration of the trademark being unsuccessful, our Group does not anticipate any material impact on our business operations. This is so as we may continue to use the trademark. In this case, however, our rights to the trademark will not be protected under the Trademarks Act 2019, and we may not be able to prevent misuse of the trademark or initiate infringement actions under the Trademarks Act 2019. Nonetheless, our Group may still enforce our rights to the trademark through common law, such as passing off actions. In addition, ICSD has an established operating track record in the industry that it operates as well as well-developed business relationships. Furthermore, ICSD operates only a part of our Group's depot business. For the FYE 2024, ICSD registered a revenue of approximately RM31.0 million, which accounted for about 2.6% of our Group's revenue for the same financial year.
