

**Summary of Amendments to the Revised Licensing Handbook
(Date of Issuance: 1 August 2018)**

The following table provides a summary of amendments made to the revised *Licensing Handbook* issued on 1 August 2018:

A. General amendments made throughout the Licensing Handbook:	
1.	Following the issuance of Guidelines on Compliance with the Continuing Professional Education Requirement (CPE Guidelines), the content of Chapter 8 of the <i>Licensing Handbook</i> on CPE will be removed. Further, the requirement on CPE-Industry Transformation Initiative (ITI) compliance is also removed from the <i>Licensing Handbook</i> with the introduction of the enhanced CPE framework.
2.	Removal of a fit and proper compliance report from Electronic Licensing Application (ELA) system to the Common Reporting (ComRep) platform, effective December 2018.
