

## MyCIF Profit-Sharing Incentive For VC/PE

### Fact Sheet

#### General Information

##### About

Malaysia Co-investment Fund (MyCIF) has introduced a new incentive in 2026 to provide opportunities for crowd investors to co-invest alongside professional Venture Capital and Private Equity (VC/PE) firms on Equity Crowdfunding (ECF) platforms. Under this incentive, MyCIF offers a profit-sharing arrangement with lead VC/PE firms to bring deals onto ECF platforms and successfully deliver returns upon the exit.

#### Eligibility Criteria

##### Lead investors

No.	Criteria	Parameter
1	Eligible lead investor	<ul style="list-style-type: none"> <li>Must be a SC registered VC/PE manager or licensed fund management company with minimum two years in operation.</li> </ul>
2	Maximum co-investment by MyCIF	Up to RM5 million per issuer
3	Co-investment ratios	<ul style="list-style-type: none"> <li>MyCIF's co-investment will be in accordance to ratios applicable to relevant schemes operator/issuer applies for (e.g. 1:4 for General Scheme, 1:2 for Food Security, ESI schemes).</li> </ul> <p>Note: For purposes of calculation, the lead investor portion will be counted as part of "private investment".</p>
4	Lead investor "skin in the game"	<ul style="list-style-type: none"> <li>Lead investor must anchor at least 25% of the total deal amount.</li> </ul> <p>Note: 25% does not include existing stakes by the lead investor, only on the new deal.</p>

5	Carried interest arrangement	<ul style="list-style-type: none"> <li>• <b>MyCIF:</b> 50% carried interest, subject to 5% p.a. hurdle rate</li> <li>• <b>Crowd investor:</b> Subject to negotiation between lead investor and the operator. This must be finalised prior to the offer and clearly disclosed to crowd investors as part of the campaign terms.</li> </ul>
6	Management fee	<ul style="list-style-type: none"> <li>• <b>MyCIF:</b> Maximum up to 2% p.a. and payable up to 5 years, only if crowd investors are charged management fees in the deal arrangement.</li> <li>• <b>Crowd investors:</b> Subject to negotiation between lead investor and the operator. This must be finalised prior to the offer and clearly disclosed to crowd investors as part of the campaign terms.</li> </ul>
7	Eligible issuers	<ul style="list-style-type: none"> <li>• Micro, small and medium enterprises (MSMEs)</li> <li>• Mid-tier companies (MTCs)</li> </ul>

### **ECF operators**

This deal is only available through ECF platforms participating in the MyCIF programme.

### **Application process**

Interested VC/PE firms can engage with MyCIF participating ECF operators to discuss the potential deals claiming this incentive.
