**GLOSSARY OF TECHNICAL TERMS**

FWT	: Freight weight tonne
hub-and-spoke transshipment model	: A logistics system where a central hub has connectivity to various non-central locations, and the central hub is used to consolidate and redistribute cargo to various locations
import/export	: Cargo that is transported into Malaysia from abroad or from Malaysia to foreign markets
intermodal	: A transportation method that involves the use of multiple modes of transport—such as rail, ship, and truck—to move goods from their origin to their destination
LED	: Light emitting diode, a highly energy-efficient light source that emits light when an electric current passes through a semiconductor
marine services	: Services that we provide services to ensure the safe and efficient movement of vessels within our port limits
move	: The handling of a container at a port of terminal, such as loading, unloading and repositioning
moves per hour	: The number of moves completed in one hour
MT	: Metric tonne
reefer	: Refrigerated container used for transporting perishable goods that need to be kept at a controlled temperature during transit
RORO	: Roll-on roll-off cargo service, which refers to a type of shipping method where cargo is driven on and off the vessel using its own wheels, such as cars, trucks, trailers, and other wheeled vehicles
RTG	: Rubber-tyred gantry crane. A type of crane that moves on wheels (typically rubber tyres), rather than on rails or tracks, used in container terminals and port operations to move shipping containers
TEU	: Twenty-foot equivalent unit
throughput	: The volume of cargo that are handled by a port or terminal over a specific period of time
transshipment	: Cargo that is transported from one destination abroad to another
STS	: Ship-to-ship transfer, which refers to the process of transferring cargo directly between two ships, typically while they are at anchor or in port, rather than unloading the cargo to a terminal or port facility
