**Batik Lestari Competition Privacy Policy**

1. The Securities Commission Malaysia (“**SC**”) respects your privacy and is committed to protecting your Personal Data. This Privacy Policy clarifies how SC Processes your Personal Data in connection with the Batik Lestari Competition (“**Competition**”) organised by the SC, the further details of which are as set out on the Competition Portal, and tells you about your privacy rights and how the law protects you.

2. It is important that you read this Privacy Policy together with the Competition T&Cs so that you are fully aware of how and why the SC is using and Processing your Personal Data.

3. In this Privacy Policy, in addition to the various other definitions as set out in other paragraphs, the following expressions shall have the following meanings:

“**Application Form**” means the application form for participating in the Competition, accessible electronically through the Submission Portal;

“**Competition Portal**” means the Competition’s portal accessible electronically at <https://www.sc.com.my/batiklestari>

“**Competition T&Cs**” means the Securities Commission Malaysia Batik Design Competition Terms and Condition, accessible electronically at <https://www.sc.com.my/batiklestari>, as may be updated by the SC in its sole discretion, such updated versions to take effect immediately upon publication on the Competition Portal or Submission Portal;

“**Entry**” has the same meaning as ascribed to it in the Competition T&Cs;

“**Personal Data**” means any information about an individual from which that person can be identified, including those as contemplated by Paragraph 5;

“**Privacy Policy**” means this Batik Design Competition Privacy Policy, accessible electronically at <https://www.sc.com.my/batiklestari>, as may be updated by the SC in its sole discretion, such updated versions to take effect immediately upon publication on the Competition Portal or Submission Portal;

“**Process**” means collecting, recording, holding or storing the Personal Data or carrying out any

operation or set of operations on the Personal Data. The words “**Processing**” and “**Processed**”, etc., shall be construed accordingly;

“**Submission Portal**” means the Competition’s submission portal accessible electronically at <https://www.sc.com.my/batiklestari>

**SC processes your personal data**

4. By participating in the Competition, you consent to the processing of your Personal Data collected by the SC for the Competition. The SC decides how to use such Personal Data and is committed to looking after it in accordance with the Personal Data Protection Act 2010 (“**PDPA**”).

5. The SC may Process different kinds of Personal Data about you which may be categorised as follows:

(a) **Identity Data**, which includes first name, maiden name, last name, username or similar identifier, marital status, title, date of birth, gender, identity card number, passport number, etc.;

(b) **Contact Data**, which includes home address, correspondence address, email address and telephone numbers, etc.;

(c) **Financial Data**, which includes bank account details, etc.;

(d) **Technical Data**, which includes Internet protocol (IP) address, your login data, browser type and version, time zone setting and location, browser plug-in types and versions, operating system and platform, and other technology on the devices you use to communicate with the SC or otherwise access the Competition Portal, Submission Portal, any website operated by the SC, etc.;

(e) **Profile Data**, which includes your username and password, your preferences, feedback and survey responses, etc.; and

(f) **Usage Data**, which includes information about how you use the SC’s website, Competition Portal, or Submission Portal.

6. The Competition is not intended for any person below the age of 18 and the SC does not

knowingly collect or Process Personal Data relating to minors.

#### **Source of personal data**

7. SC may receive your Identity, Contact and Financial Data when you fill in forms (e.g. the Application Form, or such other forms on the Submission Portal or Competition Portal) or correspond with the SC (including SC's officers) by post, phone, email or otherwise. This includes Personal Data you provide when you:

- (a) create an account on the Submission Portal;
- (b) enter the Competition or participate in any survey; or
- (c) provide the SC with feedback or contact the SC.

8. As you interact with the SC's websites including the Competition Portal and Submission Portal, SC will automatically collect Technical Data about your equipment, browsing actions and patterns. SC collects this Personal Data by using cookies, server logs and other similar technologies. SC may also receive Technical Data about you if you visit other websites employing SC's cookies. Please see SC's cookie policy at <https://www.sc.com.my> for further details.

9. SC may receive Personal Data about you from various third parties and public sources as set out below:

- (a) Technical Data from analytics providers, advertising networks, search information providers, etc.;
- (b) Contact, Financial and Transaction Data from providers of technical, payment and delivery services, etc.;
- (c) Identity and Contact Data from data brokers or aggregators, or publicly available sources such as the public electoral register,

#### **Purposes of processing**

10. The SC collects and Processes your Personal Data for purposes of the Competition, including:

- (a) to conduct the Competition;
- (b) to register you as a participant of the Competition;
- (c) to enable you to partake in the Competition and complete any related survey;
- (d) to assess and evaluate your Entry, eligibility, and your compliance with all other requirements of the Competition and Competition T&Cs;

- (e) to publicise the Competition, and promote the batik designs and materials obtained by SC through the Competition;
- (f) to manage SC's relationship with you which may include notifying you (at SC's option) about changes to the Competition T&Cs or this Privacy Policy or asking you to take a survey or participate in any interview;
- (g) to administer and maintain SC's website, the Competition Portal and the Submission Portal (including troubleshooting, data analysis, testing, system maintenance, support, reporting and hosting of data);
- (h) to use data analytics to improve SC's website, the Competition Portal and the Submission Portal, participant's engagement, user experiences, etc.;
- (i) to award you any prizes;
- (j) to identify you as a Winner, including, without limitation, through methods as described in the Competition T&Cs;

11. The SC will only use your Personal Data for the purposes for which it was collected, unless the SC reasonably considers that the Personal Data is needed to be used for another purpose and that other purpose is compatible with or related to the original purpose.

12. Please note that the SC may Process your Personal Data without your knowledge or consent, where this is required or permitted by law.

#### **Disclosure and cross-border transfer of your personal data**

13. The SC may share your Personal Data with the categories of third parties set out below for the purposes outlined above:

- (a) service providers who provide IT and cloud services, or other services in connection with the administration of the Competition;
- (b) third parties to whom the SC may choose to assign its rights and obligations in the Competition or under the Competition T&Cs and this Privacy Policy;
- (c) professional advisers including lawyers, accountants, auditors, and insurers who provide consultancy, legal, insurance and accounting services;
- (d) regulators and other authorities who may have jurisdiction over the Competition or your Personal Data; and
- (e) for the purposes permitted under law.

14. As some of the third parties contemplated above (or their facilities or equipment) may not be located within Malaysia (e.g. cloud storage

provider with data centre located in another country) your Personal Data may be transferred to places outside of Malaysia and you agree to such cross-border transfer of your Personal Data.

### **Your rights**

15. Under the PDPA, you have certain rights relating to your Personal Data the SC Processes.
16. You may enquire about whether the SC Processes your Personal Data, and request access to your Personal Data Processed by the SC. The SC will make every effort to respond to your enquiry or request within 21 days from the date of receipt of your enquiry or request.
17. Where you know that your Personal Data held by the SC is inaccurate, incomplete, misleading or not up-to-date, you may make a correction request so that your Personal Data becomes accurate, complete, not misleading and up-to-date. The SC will make every effort to respond to your request within 21 days from the date of receipt of your request.
18. You may also request for the Processing of your Personal Data or Personal Data relating to other persons who may be identified you're your Personal Data to be limited. In this regard, you may:
  - (a) withdraw your consent to the Processing of your Personal Data;
  - (b) if the Processing of Personal Data is likely to cause substantial damage or substantial distress to you or any other person, request the SC to cease the Processing of the Personal Data or not to begin the Processing of Personal Data (whether totally, or for any specific purpose, or in any specific manner); or

- (c) request the SC to cease or not to begin the Processing of Personal Data for direct marketing purposes.

19. Any enquiry and/or request made pursuant to Paragraphs 15 to 19, or any enquiry or complaint you may have regarding your Personal Data and SC's Processing thereof shall be addressed to SC's Data Protection Officer whose contact details are as follows:

### **If you fail to provide personal data**

20. It is mandatory for you to provide the SC with your Personal Data requested, if you wish to participate in the Competition, access and use the Competition Portal and Submission Portal, or in any other manner enjoy the benefit of the Competition.
21. In case of any failure to provide your Personal Data to the SC when requested, or any failure to provide your consent (to the Processing of your Personal Data) when required, the SC will not be able to allow your participation in the Competition, access and use the Competition Portal and Submission Portal, or enjoyment of the benefit of the Competition. Where any Entry has been submitted, the SC may have to cancel your Entry and terminate your participation in the Competition.

### **English version prevails**

22. This Privacy Policy is available in both Bahasa Malaysia and the English language. In case of any inconsistency between them, the English version shall prevail to the extent of the inconsistency.
