SECURITIES INDUSTRY ACT 1983

Securities Industry (Licensing of Fund Manager and Fund Manager's Representative) (Amendment) Regulations 2005

In exercise of the powers conferred by paragraph 127(2)(a) of the Securities Industry Act 1983 [Act 280], the Minister makes the following regulations:

Citation and commencement

- 1. (1) These regulations may be cited as the Securities Industry (Licensing of Fund Manager and Fund Manager's Representative) (Amendment) Regulations 2005.
 - (2) These Regulations come into operation on 18 February 2005.

Amendment of regulation 3

- 2. The Securities Industry (Licensing of Fund Manager and Fund Manager's Representative) Regulations 1996 [P.U. (A) 117/1996], which are referred to as the "principal Regulations" in these Regulations, are amended in regulation 3—
 - (a) in subregulation (1), by substituting for the words "First Schedule" the words "First Schedule and Second Schedule";
 - (b) in subparagraph (2)(b)(i), by substituting for the words "form in the prescribed manner" the words "relevant parts of the form"; and
 - (c) in subregulation (4), by inserting after the words "in the form" the words "or as may be specified by the Commission from time to time".

Amendment of regulation 4

- 3. The principal Regulations are amended by substituting for regulation 4 the following regulation:
- "Manner of sending application.
- 4. An application for a licence or renewal of a licence in the forms prescribed together with any relevant annexures shall be lodged with the Commission in the form and manner as the Commission may from time to time specify.".

Deletion of regulation 5

4. The principal Regulations are amended by deleting regulation 5.
