The Special Resolution which was tabled at the EGM in respect of the Proposed SCR:

- (i) is required to be approved by at least a majority in number of the Non-Interested Shareholders and 75% in value to the votes attached to the KCB Shares held by the Non-Interested Shareholders that are cast either in person or by proxy at the EGM; and
- (ii) the values of the votes cast against the special resolution for the Proposed SCR is not more than 10% of the votes attached to the KCB Shares held by the Non Interested Shareholders of the total voting shares of the Company;

The Proposed SCR and the Proposed WAC are inter-conditional upon each other. The Proposed SCR will not be carried out if the Proposed WAC is not implemented, or vice versa. Save for this, the Proposed SCR is not conditional upon any other corporate exercise of KCB.

Based on poll results, the Special Resolution was voted for by 98.425% in number and 99.962% in value to the votes attached to the disinterested KCB Shares that were cast either in person or by proxy at the EGM. Further, 0.003% in value of the votes attached to all disinterested KCB Shares of the total voting shares of KCB voted against the Special Resolution. Hence, the Special Resolution in respect of the Proposed SCR tabled at the EGM has been carried.
