(1) A declaration that all such monies or funds standing to the credit of the persons listed in Schedule 1 hereto ("Investors") involved in the 1st Defendant's Gold Structured Investment Scheme at the time of receipt of the same by the 1st Defendant were held by 1st Defendant upon absolute trust for each of the investors in proportion to their respective investment in the said scheme;

- (2) A declaration that the Defendants are jointly and severally liable to pay to the Plaintiff the sum of RM1,925,539.10 representing the shortfall required to fully make restitution to the Investors of the 1st Defendant's Gold Structured Investment Scheme, the Defendants having complied with prior directions to transfer to the Plaintiff, all identified monties and properties belonging in trust to the Investors;
- (3) An Order that the Plaintiff be allowed to utilize the sum of RM216,231.49 in the 1st Defendant's Maybank Account No. 514570503877 ("Account B") which is currently maintained by UOB Trustee (Malaysia) Berhad to be paid to the investors towards reducing the amount of the shortfall;
- (4) An Order that the Plaintiff be allowed to utilized the security deposit of RM150,000.00 paid by the 1st Defendant for the fund manager's license application which is currently held by the Plaintiff to be paid to the Investors towards reducing the amount of the shortfall;
- (5) An Order that the Defendants, jointly and severally, do within 7 days from the date of this Order, pay to the Plaintiff the sum of RM 1,559,307.61 representing the shortfall required to fully make restitution to the Investors less the sum in Account B and the security deposit currently held by the Plaintiff;
- (6) That notice of these proceedings and of the Orders made herein be advertised once in two local newspapers, namely Berita Harian and The Star in the form of an advertisement to be approved by the Deputy Registrar of this Court;
- (7) That the costs of and incidental to this application he paid by the Defendants;
- (8) That the Plaintiff be indomnified by the Defendants for any costs, expenses and fees incurred by the Plaintiff in respect of the appointment of the United Overseas Bank

(Malaysia) Bhd and UOB Trustee (Malaysia) Bhd ("the Trustees") and the exercise of the Trustees' duties;

- (9) Such other ancillary or further orders as this Honourable Court deems fit; and
- (10) That the Plaintiff be at liberty to apply for any ancillary or further orders as may be deemed necessary;

- (a) That 1st Defendant's Gold Structured Investment Scheme was a probibited business under the conditions of the Defendants' licenses issued under the (now repealed) Securities Industry Act, 1983;
- (b) That the Defendants published, distributed and disseminated 1st Defendants Gold Structured Investment Scheme to solicit investment without the written approval of the SC; and
- (c) That the Defendants had permitted unlicenced fund manager representatives to undertake the activities of a licenced fund manager representative.
