

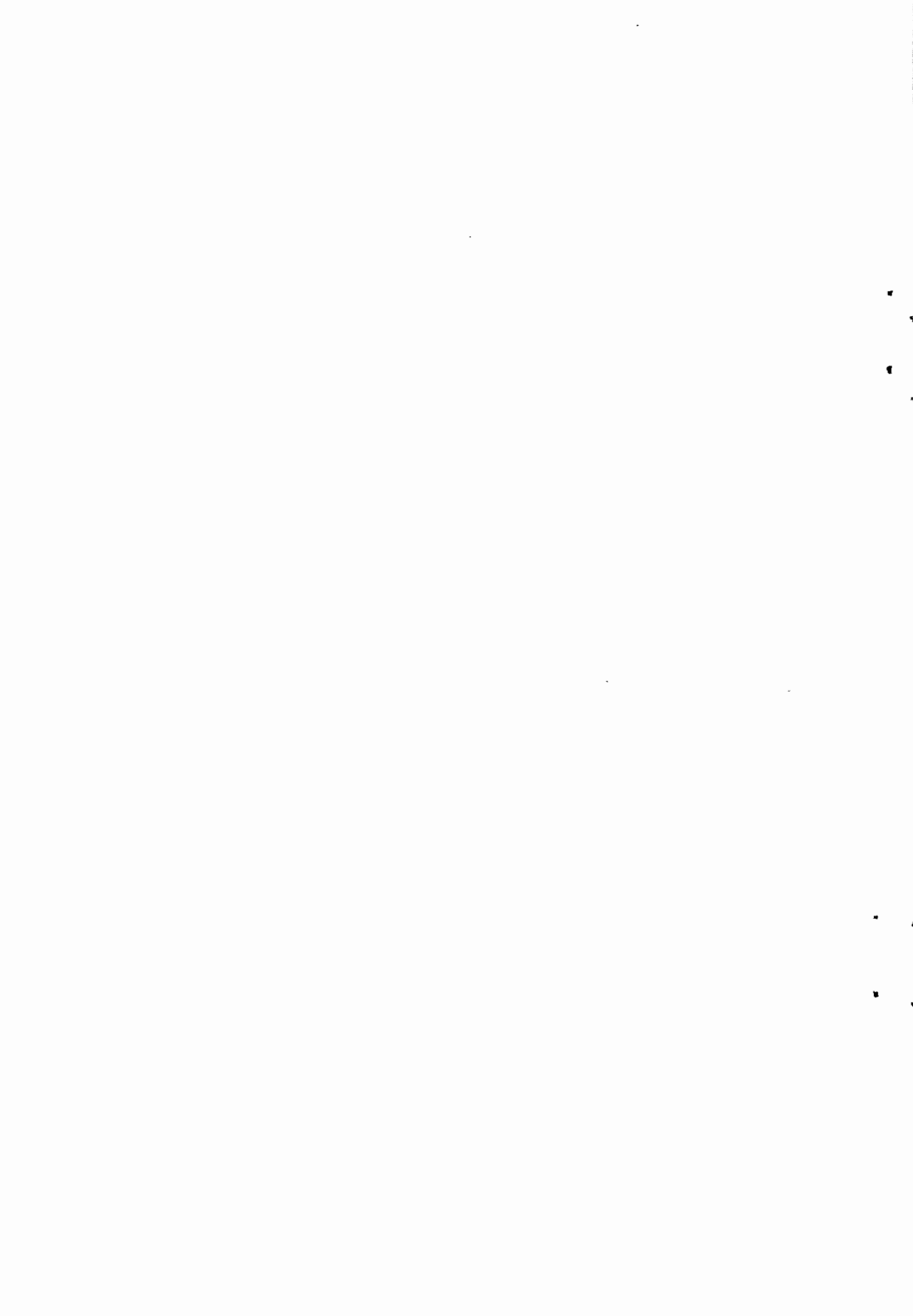

This list of securities approved by the Syariah Advisory Council of the Securities Commission will be updated and made known to the public by the Securities Commission.



The Syariah Advisory Council (SAC) of the Securities Commission (SC) has approved an updated list of securities, which have been classified as Syariah-approved securities. The securities are listed on the Kuala Lumpur Stock Exchange (KLSE) and Malaysian Exchange of Securities Dealing and Automated Quotation (MESDAQ). The list of approved securities will take effect from 26 October 2001.

Nineteen companies, newly classified by the SAC as approved securities, have been added to the list (Table 1). Six companies which were in the previous list have been excluded (Table 2). The complete list of the 642 approved securities as well as a breakdown of these securities according to sectors are provided in the Appendix.

In classifying these securities as approved securities, the SAC has applied a standard criteria i.e. focusing on the core activities of the companies listed on the KLSE and MESDAQ. Hence, companies whose activities are not contrary to the Syariah principles will be classified as approved securities. Securities will be excluded from the list of approved securities based on the following criteria:

- (i) operations based on *riba* (interest) such as activities of financial institutions like commercial and merchant banks and finance companies;
- (ii) operations involving gambling;
- (iii) activities involving the manufacture and/or sale of *haram* (forbidden) products such as liquor, pork and meat not slaughtered according to Islamic rites; and
- (iv) operations containing element of *gharar* (uncertainty) such as conventional insurance business.

For companies with activities comprising both permissible and non-permissible elements, the SAC applied several additional criteria, which are:

- (v) the core activities of the company must be activities which are not against the Syariah as outlined in the four criteria above. Furthermore the *haram* element must be very small compared to the core activities;

- (vi) public perception or the image of the company must be good; and
- (vii) the core activities of the company have importance and *maslahah* (benefit in general) to the Muslim *Ummah* (nation) and the country, and the *haram* element is very small and involves matters such as *'umum balwa* (common plight), *'uruf* (custom) and the rights of the non-Muslim community which are accepted by Islam.

Approved securities include ordinary shares, warrants and transferable subscription rights (TSRs). This means that warrants and TSRs are classified as approved securities from the Syariah perspective provided the underlying shares are also approved. On the other hand, loan stocks and bonds are non-approved securities unless their issuance are based on Islamic principles.

In classifying these securities, the SAC received input and support from the SC. The SC gathered information about the companies from various sources such as company annual financial reports, responses to a survey form which was issued to obtain detailed information and through inquiries made to the respective company's management. The SC through the SAC, will continue to monitor the activities of all companies listed on the KLSE and MESDAQ from time to time to determine their status.

As a guide to investors, the SAC would like to advise investors on the timing for the disposal of securities, which have been classified as Syariah non-approved. If, at the time the announcement is made, the value of the securities held exceeds the original investment costs, investors who hold such non-approved securities must liquidate them. Any capital gains arising from the disposal of the non-approved securities made at the time of the announcement can be kept by the investors. However, any excess capital gains from the disposal made after the announcement day at a market price that is higher than the closing price on the announcement day should be channeled to charitable bodies.

On the other hand, investors are allowed to hold their investment in the non-approved securities if the market price of the said securities is below the original investment costs. It is also permissible for the investors to keep the dividends received during the holding period until such time when the total amount of dividends received and the market value of the non-approved securities held equal the original investment cost. At this stage, they are advised to dispose of their holding.

In addition, investors during the holding period are allowed to subscribe to:

- (a) any issue of new securities by a company whose non-approved securities are held by the investors, for example rights issues, bonus issues, special issues and warrants (excluding securities whose nature is non-approved e.g. ICULS); and
- (b) securities of other companies offered by the company whose non-approved securities are held by the investors,

on condition that they are used to expedite the disposal of the non-approved securities. For securities of other companies [as stated in (b) above], they must be Syariah-approved securities.

Note : Original investment costs may include brokerage costs or related transaction costs.
